This MEMORANDUM OF UNDERSTANDING (MOU) is entered into On this the 17th Day of August 2024 by and between

WHEREAS

A. SHOBHIT INSTITUTE OF ENGINEERING & TECHNOLOGY, Meerut (SIET) has been granted Deemed to-be University Status by the Government of India, Ministry of Human Resource Development (now called Ministry of Education), Department of Higher Education vide its Notification No. F-9-37/2004-U.3 (A) dated November 8, 2006 under Section 3 of the University Grants Commission Act 1956 and Accredited with NAAC 'A' Grade, and has also been granted prestigious 12-B Status by UGC. The University is located in Meerut, Uttar Pradesh, India. It is a research-intensive, multi-disciplinary university that shares the values of high-quality teaching within an environment of internationally competitive research.

SIET believes in strategic growth as envisaged in its mission and vision, to impart quality education through vertical and horizontal integration. SIET envisions to be an internationally recognized as a premier Indian University with a global perspective, and as a brand in technical education, research and industrially relevant innovations at national and global level, and to be a key node in national and global knowledge network for research.

Considering the research contribution, the University has been recognized as Scientific and Industrial Research Organization by the DSIR, Ministry of Science and Technology, Government of India. - B. KG College of Arts and Science (KGCAS) established in the year 2005 under the auspices of KGiSL Trust. The culture of trust is "Work is Worship". The institution is recognized under 2(f) and 12(B) of UGC. The college is affiliated to Bharathiar University, accredited A++ grade with CGPA of 3.54 out of 4 by NAAC in the academic year 2022 2023. Subsequently KGCAS is conferred with autonomous status for ten years from the academic year 2024-2025. It is an ISO 9001:2015 certified institution.
- C. The KGCAS has adopted, under the Unnat Bharat Abhiyan (UBA) Programme of the Government of India, Tribal Villages in Kemmarampalayam Panchayat, Coimbatore District, Tamil Nadu. To facilitate, the (KGCAS) desires to have Shobhit Institute of Engineering and Technology (Deemed to be University) Meerut as its Mentor University to promote a Centre for Agricultural Informatics and e-Governance Research Studies (CAIRS) – A Centre for Excellence in Smart Agriculture in Tribal Areas.
- D. The Parties believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities. The Parties also intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, Placement, Industrial Visit, Expert Lecture, Collaborative Research etc.
- E. The Parties are desirous of entering this Memorandum of Understanding to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

NOW THIS MOU WITNESSES AS FOLLOWS:

ARTICLE 1: OBJECTIVE

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations, and national policies from time to time in force in each party's Institution, shall endeavor to strengthen, promote and develop academic, cultural, and research co-operation between the parties on the basis of equality and mutual benefit

ARTICLE 2: AREAS OF COOPERATION

- 2.1 Both parties agree to encourage the following activities, in particular, to promote international academic cooperation in the following areas:
 - a) Establishing a Centre of Excellence in Agricultural Informatics and e-Governance Research Studies (CAIRS) Network Research Value Chain comprising of Public Health. (Allopathy and AYUSH), Plant Health, Water Health, Soil Health, Environmental Health, Geo-informatics and Bioinformatics related to Agriculture etc., at Village level.
 - b) Introducing Programs under Industrial 4.0 To undertake Emerging technologies like AR/VR, AI and ML, BLOCK CHAIN etc., for different sectors, and also new courses to add more value so as to make students Industry 4.0 / 5.0 ready
 - c) Institutional exchanges between faculty and staff from each partner institution;
 - d) Acceptance of undergraduate and graduate students of each partner institution for periods of study and/or research;
 - e) Organization of symposia, conferences, short courses, and meetings on research issues;
 - f) Exchange of information pertaining to developments in teaching, student development, and research institutions;
 - g) Mutually promote information and activities of the other Party within the scope of the Memorandum of Understanding on their respective websites (subject to prior written approval for the use of any logos or trademarks); and
 - h) Intent to cooperate and focus their efforts on Cooperation within area of Skill Based Training, Education, Industrial Visit, Expert Lecture. Cooperation in any other areas as agreed to by the Parties from time to time.

- 2.2 For the purpose of implementing the co-operation in respect of any areas stated in paragraph 2.1, the Parties shall enter into agreements subject to terms and conditions as mutually agreed upon by the parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of disputes".
- 2.3 Any specific activity/project developed under this MOU shall be detailed in a subsequent agreement signed by each institution's authorized signatory, which will describe the scope of the proposed activity/project intended outcomes, budget and responsible departments or individuals and approval of institutions' authorized signatories.
- 2.4 Specific project shall be undertaken by both the parties on a project-to-project basis subject to availability of funds.

ARTICLE 3: FINANCIAL ARRANGEMENTS

- 3.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- 3.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding

ARTICLE 4: EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create any legally binding or enforceable obligations, or express or implied, under domestic or international law.

ARTICLE 5: NO AGENCY

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either party as the agent of the other.

ARTICLE 6: ENTRY INTO EFFECT AND DURATION

- 6.1 This Memorandum of Understanding shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature.
- 6.2 This Memorandum of Understanding shall remain in effect for a period of FIVE (5) years.
- 6.3 This Memorandum of Understanding may be extended for such further period as may be agreed upon in writing by both parties.
