# This MEMORANDUM OF UNDERSTANDING (MOU) is entered into on this 19<sup>th</sup> Day of August 2024 by and between

**SHOBHIT INSTITUTE OF ENGINEERING & TECHNOLOGY,** Meerut, Uttar Pradesh, India (hereinafter referred to as "SIET"), NAAC "A" Grade Accredited, Deemed to be University, under section 3 of UGC Act 1956, the First Party and represented by its Registrar;

AND

NIRMALA COLLEGE FOR WOMEN, COIMBATORE (AUTONOMOUS), COIMBATORE, TAMIL NADU, INDIA (hereinafter referred to as "NCW"), the Second Party and represented by its Principal.

**SIET** and **NCW** shall hereinafter be referred to singularly as "the Party" and collectively as "the Parties".

#### **WHEREAS**

(Autonomeus) Coimbatore - 641 018.

A. SHOBHIT INSTITUTE OF ENGINEERING & TECHNOLOGY, Meerut (SIET) has been granted Deemed to-be University Status by the Government of India, Ministry of Human Resource Development (now called Ministry of Education), Department of Higher Education vide its Notification No. F-9-37/2004-U.3 (A) dated November 8, 2006 under Section 3 of the University Grants Commission Act 1956 and Accredited with NAAC "A" Grade, and has also been granted prestigious 12-B status by UGC. The university is located in Meerut, Uttar Pradesh, India. It is a research-intensive, multi-disciplinary university that shares the values of high-quality teaching within an environment of internationally competitive research.

SIET believes in strategic growth as envisaged in its mission and vision, to impart quality education through vertical and horizontal integration. SIET envisions to be an internationally recognized as a premier Indian University with a global perspective, and as a brand in technical education, research and industrially relevant innovations at national and global level, and to be a key node in national and global knowledge network for research.

Considering the research contribution, the University has been recognized as Scientific and Industrial Research Organization by the DSIR, Ministry of Science and Technology, Government of India. The University has been ranked one amongst the India's Top 23 Technical Universities in India, one amongst the India's Top 3 Technical Universities in India with highest number of Patent published in the past three years, and one amongst India's Top 4 Technical Universities in Best Faculty Student Ratio at M.Tech. They work in association with Industry partners and reputed NGOs to undertake policy research and also empower the promising graduates through academic and research programs. Such programs facilitate adoption of technologies in sectors such as agriculture (Crop, Livestock and Fisheries), Industry (MSMEs) and Health, to facilitate digitalized transformation in developing countries.

B. NIRMALA COLLEGE FOR WOMEN, RED FIELDS, COIMBATORE (NCW) is a Catholic Institution of Higher Education for Women, established in the year 1948, under the direction of the religious society of the Franciscan Sisters of the Presentation of Mary founded by Rev.Fr. Joseph Louis Ravel in the year 1853. The College has now emerged as one of the premier institutions of learning, propagating higher values of education and learning, with hopes and dreams to achieve her goal "Knowledge Purifies, Charity Enhances".

Nirmala College for Women has a long tradition of service and concern for the socially and economically marginalized section of the society. The College offers a vibrant environment by creating a platform to develop students' potential. In recognition of the high academic performance and service, the College was accredited with 'A' Grade by NAAC during the academic year 2003-04 and accredited with A++ Grade by NAAC in the 4th cycle with CGPA 3.78 in the Year 2023, and was conferred the autonomous status in the year 2007.

- C. The NCW has adopted, under the Unnat Bharat Abhiyan (UBA) Programme of the Government of India, Nine Tribal Villages (Renganathapuram, Rayaruthpathi, Perumpathi, Perukaipathi, Perukaipathiputhur, Kunjurpathi, Manguli, Pasumani and Pasumaniputhur) in the Palamalai Hills, Periyanaikanpalayam Block, Coimbatore, Tamil Nadu. To facilitate, the NCW desires to have Shobhit Institute of Engineering and Technology (Deemed to be University) Meerut as its Mentor University, to promote a Centre for Agricultural Informatics and e-Governance Research Studies (CAIRS) A Centre for Excellence in Smart Agriculture in Tribal Areas.
- D. The Parties believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities. The Parties also intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, Placement, Industrial Visit, Expert Lecture, Collaborative Research etc.

## **NOW THIS MOU WITNESSES AS FOLLOWS:**

#### **ARTICLE 1: OBJECTIVE**

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations, and national policies from time to time in force in each party's Institution, shall endeavor to strengthen, promote and develop academic, cultural, and research cooperation between the parties on the basis of equality and mutual benefit.

## **ARTICLE 2: AREAS OF COOPERATION**

- 2.1 Both parties agree to encourage the following activities, in particular, to promote national and international academic cooperation in the following areas:
  - a) Establishing a Centre of Excellence in Agricultural Informatics and e-Governance Research Studies (CAIRS) Network Research Value Chain comprising of Public Health. (Allopathy and AYUSH), Plant Health, Water Health, Soil Health, Environmental Health, Geo-informatics and Bioinformatics related to Agriculture etc., at Village level.
  - b) Introducing Programs under Industrial 4.0 To undertake Emerging technologies like AR/VR, AI and ML, BLOCK CHAIN etc., for different sectors, and also new courses to add more value so as to make students Industry 4.0 / 5.0 ready.
  - c) Institutional exchanges between faculty and staff from each partner institution;
  - d) Acceptance of undergraduate and graduate students of each partner institution for periods of study and/or research;
  - e) Organization of symposia, conferences, short courses, and meetings on research issues;
  - f) Exchange of information pertaining to developments in teaching, student development, and research institutions;
  - g) Mutually promote information and activities of the other Party within the scope of the Memorandum of Understanding on their respective websites (subject to prior written approval for the use of any logos or trademarks); and

h) Intent to cooperate and focus their efforts on Cooperation within area of Skill Based Training, Education, Industrial Visit, Expert Lecture. Cooperation in any other areas as agreed to by the Parties from time to time.

- 2.2 For the purpose of implementing the co-operation in respect of any areas stated in paragraph 2.1, the Parties shall enter into agreements subject to terms and conditions as mutually agreed upon by the parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of disputes".
- 2.3 Any specific activity/project developed under this MOU shall be detailed in a subsequent agreement signed by each institution's authorized signatory, which will describe the scope of the proposed activity/project intended outcomes, budget and responsible departments or individuals and approval of institutions' authorized signatories.
- 2.4 Specific project shall be undertaken by both the parties on a project-to-project basis subject to availability of funds.

# **ARTICLE 3: FINANCIAL ARRANGEMENTS**

- 3.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.
- 3.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding

# **ARTICLE 4: EFFECT OF MEMORANDUM OF UNDERSTANDING**

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create any legally binding or enforceable obligations, or express or implied, under domestic or international law.

#### **ARTICLE 5: NO AGENCY**

Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either party as the agent of the other.

#### **ARTICLE 6: ENTRY INTO EFFECT AND DURATION**

- 6.1 This Memorandum of Understanding shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature.
- 6.2 This Memorandum of Understanding shall remain in effect for a period of FIVE (5) years.

6.3 This Memorandum of Understanding may be extended for such further period as may be agreed upon in writing by both parties.
