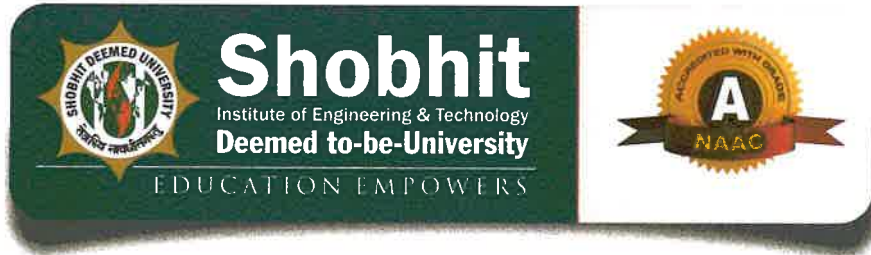


MEMORANDUM OF UNDERSTANDING (MOU)

**This MEMORANDUM OF UNDERSTANDING (MOU) is entered into
on this the 16th Day of August 2024 by and between**

SHOBHIT INSTITUTE OF ENGINEERING & TECHNOLOGY, Meerut, Uttar Pradesh, India (hereinafter referred to as “SIET”), NAAC “A” Grade Accredited, Deemed to be University, under section 3 of UGC Act 1956, the First Party and represented by its Registrar;

AND

PSGR KRISHNAMMAL COLLEGE FOR WOMEN Coimbatore (hereinafter referred to as “KCW”), the Second Party and represented by its Principal.

SIET and KCW shall hereinafter be referred to singularly as “the Party” and collectively as
“the Parties”.

WHEREAS

- A. **SHOBHIT INSTITUTE OF ENGINEERING & TECHNOLOGY, Meerut (SIET)** has been granted Deemed to-be University Status by the Government of India, Ministry of Human Resource Development (now called Ministry of Education), Department of Higher Education vide its Notification No. F-9-37/2004-U.3 (A) dated November 8, 2006 under Section 3 of the University Grants Commission Act 1956 and Accredited with NAAC “A” Grade has also been granted prestigious 2-B status by UGC. The university is located in Meerut, Uttar Pradesh, India. It is a research-intensive, multi-disciplinary university that shares the values of high-quality teaching within an environment of internationally competitive research.

SIET believes in strategic growth as envisaged in its mission and vision, to impart quality education through vertical and horizontal integration. SIET envisions to be an internationally recognized as a premier Indian University with a global perspective, and as a brand in technical education, research and industrially relevant innovations at national and global level, and to be a key node in national and global knowledge network for research.

Considering the research contribution, the University has been recognized as Scientific and Industrial Research Organization by the DSIR, Ministry of Science and Technology, Government of India. The University has been ranked one amongst the India's Top 23 Technical Universities in India, one amongst the India's Top 3 Technical Universities in India with highest number of Patent published in the past three years, and one amongst India's Top 4 Technical Universities in Best Faculty Student Ratio at M.Tech. Apart from different Faculties, Schools, and Departments in niche academic and research areas, the University has established Specialized Centers for strengthening National Vision. To name few Centers of Excellence (COEs) are, Centre for Agricultural Informatics & e-Governance Research Studies (CAIRS), Centre for Informatics Development Solutions and Applications (CIDSAs) and Centre for Health Informatics and Computing (CHIC). They work in association with Industry partners and reputed



NGOs to undertake policy research and also empower the promising graduates through academic and research programs. Such programs facilitate adoption of technologies in sectors such as agriculture (Crop, Livestock and Fisheries), Industry (MSMEs) and Health, to facilitate digitalized transformation in developing countries.

- B. **PSGR Krishnammal College for Women, Coimbatore (KCW)**, established in 1963 under the auspices of the GRG Trust, founded in 1958 by Sri G.R. Govindarajulu (1919-1986) and Smt. Chandrakanthi Govindarajulu (1924-2002). With a motto of 'Empowering Women through Education', KCW has established itself as a leader in women's education over a span of six decades.

KCW is an autonomous institution, affiliated to Bharathiar University, Coimbatore. It is ranked #4 among colleges in the country in 2023 by the National Institutional Ranking Framework (NIRF) of the Ministry of Education, Government of India. The college is accredited by the National Assessment and Accreditation Council (NAAC) with the highest A++ grade (score of 3.71 out of 4). KCW is also a certified 'College of Excellence' by the University Grants Commission (UGC). The MBA programme is internationally accredited by the ACBSP, the only 'women-only' institution in South Asia to be so accredited. KCW is home to 8,500+ students and 425+ faculty members. The college offers 36 Undergraduate, 17 Postgraduate, and 13 Doctoral programmes in Arts & Humanities, Physical & Life Sciences, Computational Sciences, Commerce & Business, Management, and Vocational Studies.

All the Science Departments have been recognized with 'Star Status' by the Department of Bio-Technology, Ministry of Science and Technology, Government of India. The GRG-BIRAC EYUVA Centre one of the 10 Centres in India has been established with the support of BIRAC (Biotechnology Industry Research Assistance Council) of the Government of India. Interdisciplinary innovative research in sciences is augmented through the support of the DBT-BUILDER, DST-FIST, DST-CURIE, Ministry of Science and Technology. KCW has been recognized as a Nodal Training Institute under the Agri-Clinics & Agri-Business Centres (ACABC) programme launched by the Ministry of Agriculture and Farmers Welfare, Government of India, in association with NABARD. The Centres of Excellence in Life Sciences, Material Sciences, Commerce Professionals and Apparels, Made-ups and Home Furnishings are engaged in cutting-edge research in emerging fields of study. A Rural Women Technology Park (DST-sponsored) has been launched to empower women in rural areas through technology transfer and entrepreneurship. The College is a recognized Skill Satellite Centre under DSIR. The Unnat Bharat Abhiyan (UBA), a significant initiative launched by the Ministry of Education, has been implemented since 2014 with a focus on women's participation through village adoption, participatory approaches, capacity building, technology transfer and innovation, monitoring and evaluation, and knowledge networking.

- C. To facilitate, the KCW desires to have Shobhit Institute of Engineering and Technology (Deemed to be University) Meerut as its Mentor University, to promote establishing a Centre of Excellence in Health Informatics (CHIC) to promote Health Informatics Network Research Value Chain in rural areas.



- D. The Parties believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities. The Parties also intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education, Placement, Industrial Visit, Expert Lecture, Collaborative Research etc.
- E. The Parties are desirous of entering this Memorandum of Understanding to declare their respective intentions and to establish a basis of cooperation and collaboration between the Parties upon the terms as contained herein.

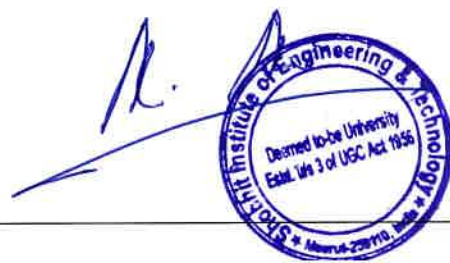
NOW THIS MOU WITNESSES AS FOLLOWS:

ARTICLE 1: OBJECTIVE

The Parties, subject to the terms of this Memorandum of Understanding and the laws, rules, regulations, and national policies from time to time in force in each party's Institution, shall endeavor to strengthen, promote and develop academic, cultural, and research co-operation between the parties on the basis of equality and mutual benefit.

ARTICLE 2: AREAS OF COOPERATION

- 2.1 Both parties agree to encourage the following activities, in particular, to promote international academic cooperation in the following areas :
- a) **Establishing a Centre of Excellence in Health Informatics (CHIC)** to promote Health Informatics Network Research Value Chain comprising of Public Health (Allopathy and AYUSH), Plant Health, Animal Health, Fishery Health, Water Health, Soil Health and Environmental Health etc., at Village level.
 - b) Introducing Programmes under Industrial 4.0 - To undertake Emerging technologies like AR/VR, AI and ML, BLOCK CHAIN etc., for different sectors, and also new courses to add more value so as to make students Industry 4.0 / 5.0 ready.
 - c) Institutional exchanges between faculty and staff from each partner institution;
 - d) Acceptance of undergraduate and graduate students of each partner institution for periods of study and/or research;
 - e) Organization of symposia, conferences, short courses, and meetings on research issues;
 - f) Exchange of information pertaining to developments in teaching, student development, and research institutions;
 - g) Mutually promote information and activities of the other Party within the scope of the Memorandum of Understanding on their respective websites (subject to prior written approval for the use of any logos or trademarks); and



h) Intent to cooperate and focus their efforts on Cooperation within area of Skill Based Training, Education, Industrial Visit, Expert Lecture. Cooperation in any other areas as agreed to by the Parties from time to time.

2.2 For the purpose of implementing the co-operation in respect of any areas stated in paragraph 2.1, the Parties shall enter into agreements subject to terms and conditions as mutually agreed upon by the parties including clauses on "confidentiality", "suspension", "protection of intellectual property rights" and "settlement of disputes".

2.3 Any specific activity/project developed under this MOU shall be detailed in a subsequent agreement signed by each institution's authorized signatory, which will describe the scope of the proposed activity/project intended outcomes, budget and responsible departments or individuals and approval of institutions' authorized signatories.

2.4 Specific project shall be undertaken by both the parties on a project-to-project basis subject to availability of funds.

ARTICLE 3: FINANCIAL ARRANGEMENTS

3.1 This Memorandum of Understanding shall not give rise to any financial obligation by one Party to the other.

3.2 Each Party shall bear its own cost and expenses in the implementation of this Memorandum of Understanding

ARTICLE 4: EFFECT OF MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding serves only as a record of the Parties' intentions and does not constitute or create any legally binding or enforceable obligations, or express or implied, under domestic or international law.

ARTICLE 5: NO AGENCY

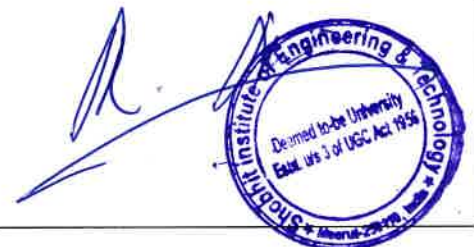
Nothing contained herein is to be construed so as to constitute a joint venture partnership or formal business organization of any kind between the Parties or so to constitute either party as the agent of the other.

ARTICLE 6: ENTRY INTO EFFECT AND DURATION

6.1 This Memorandum of Understanding shall become effective as of the date of signatures of both parties, or if the dates vary, then the date of the later signature.

6.2 This Memorandum of Understanding shall remain in effect for a period of FIVE (5) years.

6.3 This Memorandum of Understanding may be extended for such further period as may be agreed upon in writing by both parties.



ARTICLE 7: TERMINATION

This Memorandum of Understanding may be terminated by either party with a minimum of THIRTY (30) days Written Notice. Activities in progress at the time of termination of this Memorandum of Understanding shall be permitted to conclude as planned unless otherwise agreed.

ARTICLE 8: NOTICES

Any communication under this Memorandum of Understanding shall be in writing in the English language and delivered by registered mail to the address or sent to electronic mail address of SIET or KCW, as the case may be, shown below or to such other address or electronic mail address as either Party may have notified the other Party and shall, unless otherwise provided herein, be deemed to be duly given or made when delivered to the recipient at such address or electronic mail address or other address which is duly acknowledged:
