NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

- 1.2 First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities.

CLAUSE 2: SCOPE OF THE MOU

- 2.1 Industrial Training & Visits: Industry and Institution interaction will provide an insight into the latest developments / requirements of the industries; the Second Party to permit the Faculty and Students of the First Party to visit its group companies and also involve in Industrial Training Programs for the First Party. - 2.2 **Placement of trained students**: Second Party will actively engage to help the delivery of the training and placement of the students of the first party on the technology trends and in house requirements. First party will provide all necessary expertise in strengthening the placement cells of Institutions of second party.

CLAUSE 3: SPECIAL SERVICES

- 3.1 Whenever solicited by the Second party, the First party shall actively engage and help Second party in establishing the services like Consultancy services in identifying, fixing, proper faculty, training the faculty, advise and coordinate collaborations with Domestic as well as International Universities, Institutions, support students looking for academic opportunities abroad.
- 3.2 The first party, shall provide services for establishing Centers of Excellence as per needs of the second party through mutually agreed basis.
- 3.3 Both parties shall have separate agreements / MoUs for specific purposes as per needs during the course of regular interactions.

CLAUSE 4: FINANCIAL COMMITMENTS

- 4.1 There is no financial commitment on the part of both sides to take up any program mentioned in General Clauses (A) to (F) and Clauses 1 to 2 of MOU. If there is any financial consideration arise, it will be dealt separately and done as mutually agreed upon.
- 4.2 When Special services solicited by the Second party as under Clause 3, sections 3.1 to 3.3, the same shall be finalized on mutually agreed Technical and Commercial Terms from time to time.
