

## MEMORANDUM OF UNDERSTANDING (MoU)

BETWEEN

Shobhit Institute of Engineering & Technology (Deemed to-Be-University), Meerut, India

AND

KAUSHALYA-SKILL UNIVERSITY, GUJARAT

### 1. Parties

Shobhit Institute of Engineering & Technology Meerut, India Deemed-to-be University status granted by the Government of India, Ministry of Human Resource Development, Department of Higher Education vide its Notification No. F-9-37/2004-U.3(A) dated November 8, 2006 under section 3 of the University Grants Commission Act 1956.) (hereinafter referred to as Deemed University) on the First Part,

and

KAUSHALYA - SKILL UNIVERSITY, GUJARAT, under the Labour, Skill Development and Employment Department, Government of Gujarat, through Dr. Anju Sharma, IAS, Additional Chief Secretary: Labour, Skill Development and Employment Department (hereinafter referred to as KSU) on the Second Part.

### 2. Purpose

- a. The broad objective of this MoU is academic collaboration between both the parties.
- b. The specific purpose of this MoU is that First and Second Party will jointly undertake joint research activities. formulate joint research projects and co-guide PhD students enrolled by KSU in the various domain Cell and Tissue Engineering, Nanotechnology, Phytoremediation, Plastic Degradation, and Medicinal Mushroom etc
- c. The parties do not intend to be legally bound to each other, and this MoU does not impose legal obligations on either party.

### 3. Nodal Officers

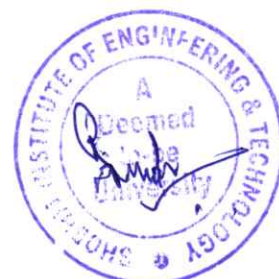
Each party to this MoU will appoint one person to act as a Nodal Officer in the execution of this MoU

### 4. Duration of MoU

- a. This MoU will be effective upon signature by each party representative for a period of five years, at which time it will be reviewed for possible renewal for another five-year period.
- b. The agreement can be terminated by each party by submitting a written application along with explanation which will terminate both parties' commitments to future but not to existing stakeholders. Upon termination or expiry of agreement both parties should continue to deliver services to existing activities to its completion.

### 5. Terms of MoU

- a. All activities conducted under this MoU will be in accordance with all applicable rules and regulations of both the parties and all applicable central, state and local laws, rules and regulations. If there is any dispute it will be resolved mutually, failing which the matter should be referred to arbitrator who shall be appointed with consent of both the parties. This MoU Shall be governed by and construed in accordance with the laws of MoU between



Shobhit Institute of Engineering & Technology Meerut & KSU. All disputes arising out of or related to this MOU, including without limitation all matters connected with its performance, will be governed by, and construed and interpreted under the laws of India, without reference to conflict of laws principles. All disputes and differences arising out of or in connection with this MoU shall be the first instance referred to arbitration by three (3) arbitrators, jointly appointed by Parties. The decision and award determined by such arbitration will be final and binding upon the Parties. The arbitration will conduct in accordance with the Arbitration and Conciliation Act, 1996, as may be in force time to time. The arbitration proceeding will be conducted in English or Gujarati and the seat of arbitration will be Ahmedabad.


