This MOU has been entered into by and between both the parties on the following terms and conditions:

1. Scope of this MOU

The scope of the MOU is to strengthen the ties between both the parties for the collaborative efforts in organizing the activities of mutual consent to spread the legal awareness, campaign and campaigns related to awareness about the social causes of mutual consents and organizing the outreach activities related to Legal Aid, Conferences, seminars and other related activities.

The "First Party" will provide the training to the volunteers/workers/employees of the "Second Party" on the request of the "Second Party".

Terms and Condition of the MoU

- ii. The "Second Party" shall cooperate in organization of outreach activities and awareness campaigns of mutual consent.
- iii. The "First Party" shall inform to the "Second Party" about any of the activity planned well in advance and the "Second Party" is free to accept or deny if it is not deemed fit and vice-versa.

2. DURATION

This Memorandum of Understanding will enter into force on the day of the last signature affixed by the PARTIES and shall remain in force until terminated by either Party.

This MOU shall be valid for five year from the date of enforcement of the MoU or the date on which the MoU comes into existence by signing both the parties. The MoU may be extended for such further period(s) and on such terms and conditions with mutual consent of both the parties. Either Party may terminate this Memorandum of Understanding upon fourteen (14) days' written notice to the other.
