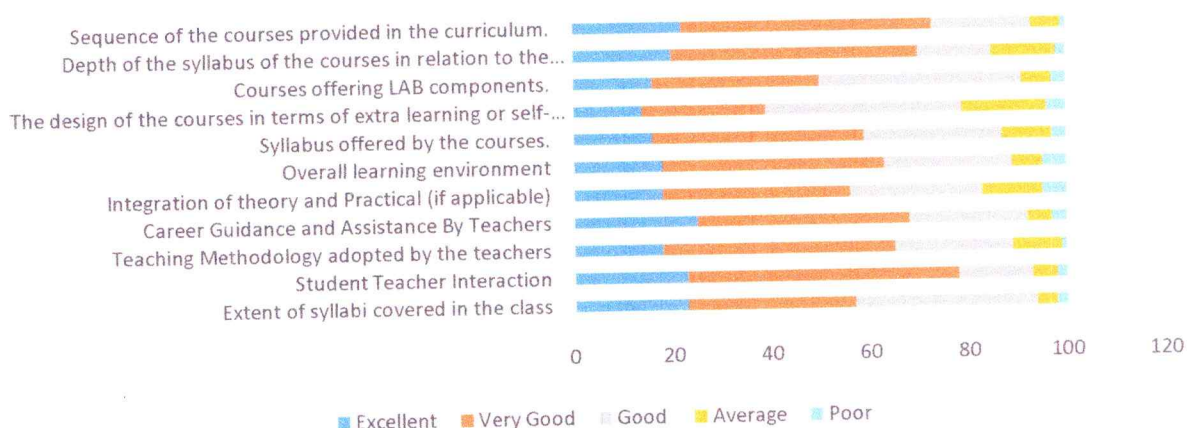


Figure1: Student Analysis (Histogram)

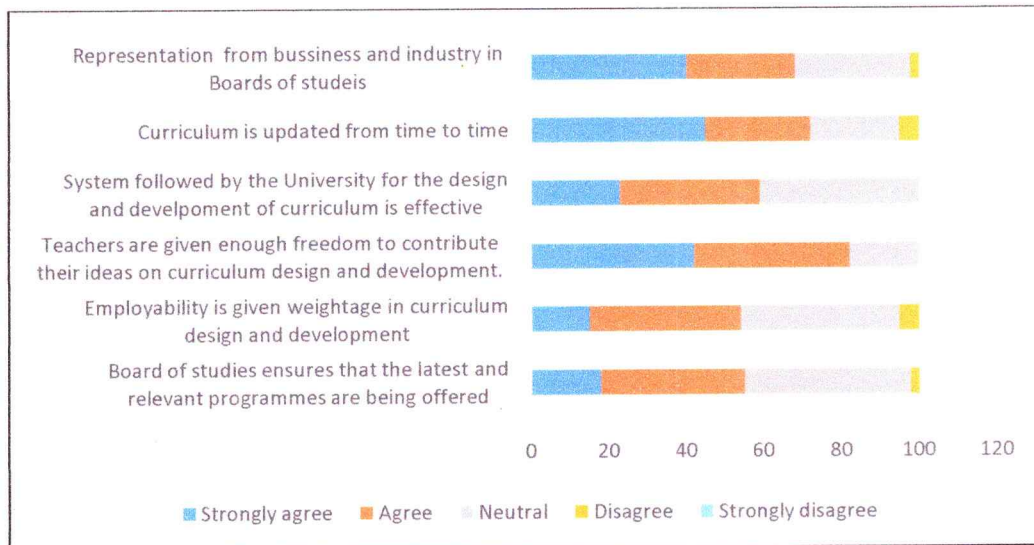


Figure 2: Faculty Feedback Analysis (Histogram)

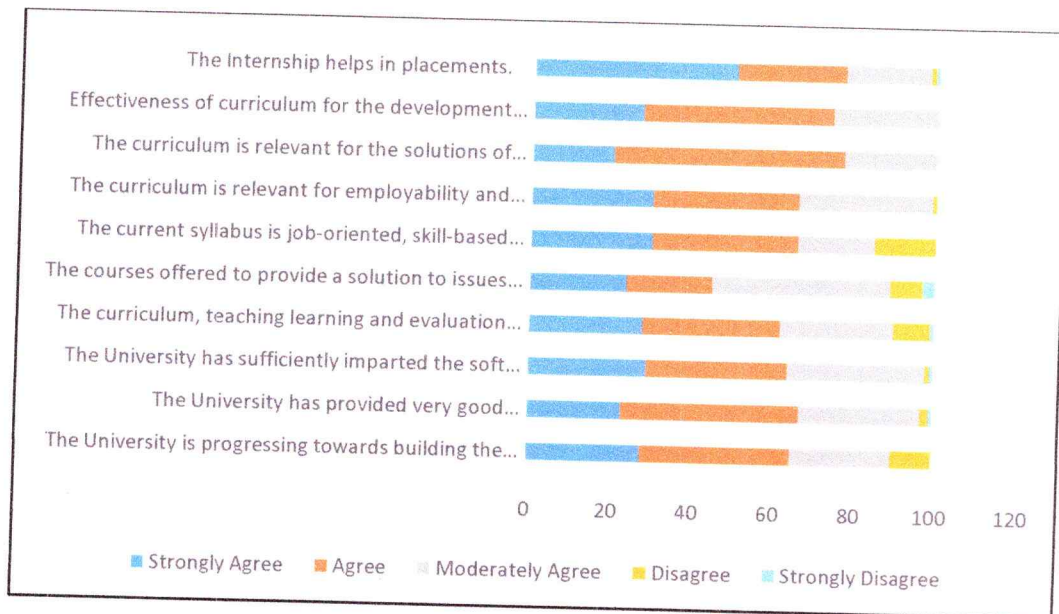



Figure3: Employers feedback Analysis



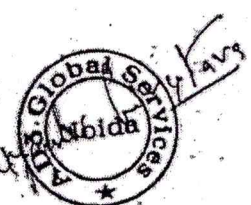

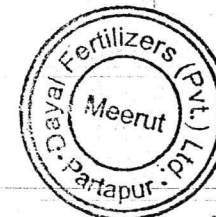
